

## TOWN BOARD MEETING MINUTES

**Date:** July 10, 2023

**Call to Order Town Board Meeting:** Chairperson Tom Winker called the Town Board Meeting to order at 6:01 p.m. Quorum established. Pledge of Allegiance recited. Verification of compliance with WI Open Meetings Law.

**In Attendance:** Supervisors Bill Janeshek, Clerk Anne Nord, Treasurer Dayle Parks, Zoning Administrator Charlie Parks, and 10 interested persons, Mitch Maersch from the Ozaukee Press and Rodney Schroeder from the Sounder. Tom Bichler excused.

**Minutes:** Motion 1: Janeshek to second: Winker to approve the minutes of the June Town Board meeting;

all voted in favor. Motion carried unanimously.

**Old Business:** Increase of shared revenue to \$54,500- we'll get about \$74,000 in total. Will not get the GTA increase of 2% from the state government for roads work for upcoming year. Smaller municipalities no longer qualify for this transportation aide- the state will instead be providing that funding to larger municipalities.

- Denny Rahn will start in 15 working days, give or take- end of July/beginning of August

**Transfer Site:**

- Tom Bichler was excused
- Ron stated: People still complaining about the 1:30
- Small hydraulic hose broke, Tom got it fixed

**New Business:**

- a. Jeremy Risch land combination: town allowed for rezone and separation of that property on the condition that the remaining land be combined. Jeremy was not present- will move this item to next months agenda

- b. Grant Schwabenlender structure removal: received a letter stating they will have the structure down by August 1.
- c. Silver Beach Paving award: Bill stated he received one bid from Payne and Doland Inc, 23 binding coat: \$184,893.75; 24 surface course: \$143,772
  - Winker motioned to approve the bid and Janeshek seconded it
