

TOWN BOARD MEETING MINUTES

December 7, 2020

Call to Order Town Board Meeting: Chairperson Tom Winker called the Town Board Meeting to order at 7:00 p.m. Pledge of Allegiance recited. Quorum established. Verification of compliance with WI Open Meetings Law.

In Attendance: Supervisors Bill Janeshek and Tom Bichler, Treasurer Dayle Parks, Clerk Ginger Murphy, Zoning Administrator Charlie Parks, Ron Swihart, Dennis Dimmer, Bob Hubing, David Balling, and one interested person, and Mitch Maersch from the *Ozaukee Press* and Rodney Schoeter from the *Sounder*.

Minutes: Motion Bichler/Janeshek to approve the minutes of the November 9, 2020, Town Board meeting; all voted in favor.

Zoning Permits: Charlie Parks reported zoning permits issued in November:
#30 Marcy Peterson, Sauk Trail Rd – 30 x 50 detached garage

Roads: Nothing new to report.

Transfer Site: Nothing new to report.

Noll Property Update: Craig Noll's property at 2324 Cty Rd A has been a topic of complaints due to incomplete renovations. Renovations were started in 2014, and the home is currently without siding since. Tom Bichler and Charlie Parks met with Craig Noll and neighbors in an attempt to establish a time line to proceed with the renovation, but not much progress was made. The current Town of Belgium Zoning Ordinance does not place a deadline or expiration date on the zoning permits, therefore, the Plan Commission will address the issue for inclusion of commencement and completion of projects issued a zoning permit. Progress on Mr. Noll's property will be assessed again in six months.

Tax Levy 2020 Payable 2021: The Clerk distributed tax rate information for 2021.

Lakeside Foods Road Spillage Complaints: Tom Winker talked to a manager at Lakeside about the messy roads due to their beet processing and was assured steps would be taken to remedy the problem. In spring of 2021, before harvest, the Board will take a look at what Lakeside has put in place to keep their spillage under control. Lakeside has been informed their current process is not acceptable.

Election Inspector Appointments: The Town Board appointed Kathy Swihart, Gerri Bichler, Ron Swihart, David Shaw, Lorraine Hartmann and Denise Dimmer election inspectors for a 2-year term beginning January 1, 2021, through December 31, 2022.

Plan Commission Appointments: The Town Board appointed Charlie Parks and Al Poull as plan commission members for a 3-year term beginning January 1, 2021, through December 31, 2024.

Board of Appeals Appointments: The Town Board appointed Gerry Gantner as board of appeals members for a 3-year term beginning January 1, 2020, through December 31, 2024.

Citizen Input: None.

Audit the Bills: Monthly invoices were audited and ordered paid.
